Councilmember Putterman moved, Councilmember Wiener seconded, to adjourn the meeting at 6:26 p.m.


Councilmembers Putterman, Rouse, Wiener, and Woodruff voted "Aye", "Noes" none.

Planning and Zoning Members Abrams, Bucci, Ly, Mathews, Murphy, and Roth voted "Aye", "Noes" none.


