In August 2018, we had the following criminal incidents in the Residential District of Hedwig <u>Village:</u>

Assault

On August 3, 2018, a dispute between two males on Magdalene resulting in one of the males being arrested for Assault.

Fraud/Identity Theft

On August 9, 2018, a resident on Echo Hollow reported that he was duped into purchasing gift cards for someone who called his phone claiming to be from Apple security.

On August 30, 2018, a resident on Heather Court reported that his AT&T account was used to fraudulently purchase a cell phone.

Harassment

On August 27, 2018, a resident on Falling Leaf reported being harassed while walking home.

Theft

On August 9, 2018, a resident on Echowood reported lawn equipment was stolen from in front of the garage of the residence.

On August 9, 2018, a resident of the Memorial Green Townhomes reported a frying pan was stolen from the back patio of the apartment.
